6 Be It Enacted by the Legislature of the State of Wyoming:

8 **Section 1.** W.S. 11-30-116 is created to read:

- 10 11-30-116. Interference with an agricultural
- 11 operation; penalty.

13 (a) As used in this section:

"Agricultural operation" 1 (i) means private property used for the production of livestock or livestock 2 3 products; 4 5 (ii) "Livestock" means as defined in W.S. 11-30-114. 6 7 (b) A person is guilty of interference with 8 9 agricultural operation if the person: 10 (i) Without consent from the owner or manager of 11 agricultural operation, knowingly or intentionally 12 13 records an image of or sound from the agricultural operation by concealing or placing a recording device on 14 the premises of the agricultural operation; 15 16 17 (ii) Without consent from the owner or manager of the agricultural operation, knowingly or intentionally 18 records an image of or sound from the agricultural 19 20 operation while committing criminal trespass under W.S. 21 6-3-303; 22 Obtains (iii) agricultural 23 access to an

operation under false pretenses; or

2 (iv) While employed at and present on an

3 agricultural operation, records an image of or sound from

4 the agricultural operation if the person:

6 (A) Applied for employment at an

7 agricultural operation with an intent to record an image or

8 sound from the agricultural operation; and

10 (B) Knew at the time the person accepted

11 employment that the owner of the agricultural operation

12 prohibits the employee from recording an image or sound

13 from the agricultural operation.

15 (c) Any person who violates any provision of this

16 section shall be punished as provided in W.S. 11-1-103.

21 11-1-103. Penalty for violations.

23 A person who violates any of the following sections commits

24 a misdemeanor punishable by imprisonment for not more than

- 1 six (6) months, a fine of not more than seven hundred fifty
- 2 dollars (\$750.00), or both for the first offense, or by
- 3 imprisonment for not more than one (1) year, a fine of not
- 4 more than one thousand five hundred dollars (\$1,500.00), or
- 5 both for second or subsequent offenses: W.S. 11-6-210(a) or
- 6 (f), 11-18-112, 11-19-101, 11-19-102, 11-19-103, 11-19-111,
- 7 11-19-401, 11-20-114, 11-20-117, 11-20-229, 11-20-230,
- 8 11-21-104, 11-22-118, 11-23-106, 11-23-207, 11-24-106,
- 9 11-29-106(b), 11-30-114, 11-30-116 and 11-48-102. A person
- 10 who violates board rules promulgated pursuant to W.S.
- 11 11-18-103(a)(v) shall be subject to the penalties specified
- 12 in this section.

- 18 (a) Any peace officer, agent or officer of the board
- 19 may lawfully interfere to prevent the perpetration of any
- 20 act of cruelty upon any livestock animal in his presence.
- 21 Any person who interferes with, obstructs or resists any
- 22 peace officer or officer or agent of the board in the
- 23 discharge of his duty shall be fined not less than two
- 24 hundred dollars (\$200.00) nor more than one thousand five

hundred dollars (\$1,500.00), or imprisoned not more than 1 2 one (1) year, or both. 3 4 (b) Any person who knows that a livestock animal is 5 being cruelly treated as defined in W.S. 6-3-203 shall report the information immediately to the owner or manager 6 of the agricultural operation or any peace officer, agent 7 or officer of the board within forty-eight (48) hours. 8 9 Anyone who in good faith makes a report pursuant to this subsection is immune from civil liability for making the 10 11 report. A failure to report cruelty under this subsection is a misdemeanor punishable as provided in W.S. 11-1-103. 12 13 Section 3. This act is effective July 1, 2013. 14
